5. Sealed or electronic bids must be submitted to the Khaptad-Chhededaha Rural Municipality, Bajura by hand or through PPMO website www.bolpatra.gov.np. on or before 12:00 hours on 2076/1/30. Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 1:00 hours on 2076/1/30 at the Khaptad-Chhededaha Rural Municipality, Bajura Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid.
7. If Bidder wish to Submit the bid security in the form of cash bidder has to deposit cash in dharauti Account No 06108109220014 of Khaptad-Chhededaha Rural Municipality, Bajura at Himalayan Bank Ltd. Branch, Dogdi, Bajura and Submit Bank Deposit Voucher along with a Bid.
8. **Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non-responsive.**
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. **All the Bidder who submit the Bid electronically are requested to submit their original hard Copy of Bid within 7 (Seven) days after dead line of submission of Bid. Failure to submit the original hard copy of bid within specified period shall be ground for declaring the bid non-responsive.**
11. Khaptad Chhededaha Rural Municipality Office, Bajura. Reserves Right to accept or Reject any or all bids, The bidding process and reject all Bids without Assigning any Reason or whatsoever.
